**WRIT OF MANDAMUS:  
JUSTICE FOR ROLIN, JUSTICE FOR ALL  
STOP ELECTION FRAUD AND PUBLIC  
MANIPULATION**

**INTRODUCTION:**

**PURPOSE:** TO ADDRESS SEVERE BREACHES OF PUBLIC TRUST INVOLVING THE TRAGIC DEATH OF ROLIN HILL AND ALLEGED MISCONDUCT, ABUSE, AND A CONTINUING COVER-UP WITHIN THE VIRGINIA BEACH JAIL AND LOCAL JUSTICE AND POLITICAL SYSTEMS. THIS WRIT SEEKS TO EXPOSE AND HALT ONGOING EFFORTS TO DISTORT PUBLIC PERCEPTION BY WITHHOLDING CRUCIAL VIDEO FOOTAGE AND OTHER RELEVANT DETAILS FROM THE PUBLIC. THIS SUPPRESSION HAS ALREADY DISTORTED THE NOVEMBER 5, 2024, ELECTION AND APPEARS INTENDED TO CONTINUE MANIPULATING OUR ELECTIONS AND GOVERNANCE SYSTEMS, OBSTRUCTING JUSTICE FOR ROLIN AND UNDERMINING INTEGRITY IN PUBLIC OFFICE.

## **STATEMENT OF FACTS:**

**DEATH OF ROLIN HILL:** ON JUNE 4, 2024, ROLIN HILL WAS HOSPITALIZED AFTER REPORTEDLY BEING BRUTALLY BEATEN AND RESTRAINED BY FIVE VIRGINIA BEACH SHERIFF'S DEPUTIES. DURING THIS RESTRAINT, MR. HILL WAS WRAPPED IN PALLET SHRINK WRAP, SEVERELY COMPROMISING HIS ABILITY TO BREATHE. HE WAS PRONOUNCED DEAD ON JUNE 10, YET THE PUBLIC WAS ONLY TOLD OF A "MEDICAL EMERGENCY" ON JUNE 4, 2024.

**PATTERN OF ABUSE:** A RECENT FOIA RESPONSE REVEALED THAT 19 INDIVIDUALS HAVE DIED IN THE VIRGINIA BEACH JAIL OVER THE PAST SEVEN YEARS, RAISING SIGNIFICANT CONCERNS ABOUT CONDITIONS AND OVERSIGHT. PETITIONERS HAVE COLLECTED INFORMATION FROM NUMEROUS INDIVIDUALS ALLEGING CRIMINAL ABUSE IN THE FACILITY.

**OCTOBER 17 AA PAC EVENT:** PETITIONERS BELIEVE THAT A QUESTION RAISED AT THE OCTOBER 17, 2024 AA PAC EVENT REGARDING INMATE ABUSE PROMPTED THE SUDDEN RELEASE OF AN OCTOBER 18 PRESS STATEMENT ANNOUNCING THE HOMICIDE DETERMINATION AND SUBSEQUENT FIRING OF FIVE DEPUTY SHERIFFS IN ROLIN HILL'S CASE.

**WITHHELD VIDEO EVIDENCE:** ONLY RECENTLY WAS THE PUBLIC INFORMED THAT FOOTAGE FROM 32 CAMERAS EXISTS DOCUMENTING THE INCIDENT. HOWEVER, THIS VIDEO FOOTAGE HAS NOT BEEN RELEASED TO THE PUBLIC. ADDITIONALLY, A SHADOW-WHISTLEBLOWER HAS ALLEGED THAT SOME OR ALL OF THIS EVIDENCE MAY HAVE BEEN DESTROYED, FURTHER CONTRIBUTING TO CONCERNS OF A COVER-UP.

**REPUBLICAN PARTY KNOWLEDGE AND PROMOTION:** OFFICIALS, INCLUDING REPUBLICAN PARTY MEMBERS, SHERIFF HOLCOMB, MAYOR DYER, AND OTHERS, LIKELY KNEW DETAILS OF ROLIN'S HOMICIDE.

**BOTH SHERIFF HOLCOMB AND MAYOR DYER WERE ENDORSED AND HEAVILY PROMOTED BY THE REPUBLICAN PARTY ON CAMPAIGN FLYERS, AIMING TO CAPITALIZE ON SUPPORT FROM PRESIDENT TRUMP. PEACEMAKER ALDO AND HIS POSSE MADE EFFORTS TO INFORM REPUBLICAN PARTY MEMBERS ABOUT ROLIN'S CASE, BUT WERE BLOCKED FROM SHARING DETAILS, INCLUDING AT A RECENT BREAKFAST EVENT.**

**IMPACT ON ELECTIONS: PEACEMAKER ALDO AND HIS POSSE HAVE MET MANY CITIZENS WHO, UPON LEARNING OF ROLIN'S DEATH AND JAIL CONDITIONS, EXPRESSED THEY WOULD NOT HAVE SUPPORTED OR VOTED FOR SHERIFF HOLCOMB IF INFORMED EARLIER. THE COURTS HAVE DELAYED RELATED FILINGS. THIS DELIBERATE DELAY IN CRITICAL, TIMELY DISCLOSURES DISTORTED THE NOVEMBER 5, 2024, ELECTION, ALLOWING KEY OFFICIALS TO RETAIN POWER WITHOUT PUBLIC SCRUTINY.**

**ONGOING STATE POLICE INVESTIGATION: THE FALSE ONGOING INVESTIGATION BY THE VIRGINIA STATE POLICE CONTINUES THE COVER-UP AND DISTORTING OF GOVERNANCE AND ELECTION RESULTS BY WITHHOLDING CRITICAL INFORMATION FROM THE PUBLIC.**

**UNLAWFUL SWEARING-IN OF SHERIFF HOLCOMB: THE 2023 UNLAWFUL SWEARING-IN OF SHERIFF ROCKY HOLCOMB BY CHIEF JUDGE LEWIS IS ENABLING THE CONTINUATION OF ENTRENCHED CORRUPTION. PETITIONERS ASSERT THAT THIS ACT BY CHIEF JUDGE LEWIS IS PART OF A BROADER EFFORT TO SHIELD OFFICIALS FROM ACCOUNTABILITY AND OBSTRUCT JUSTICE.**

**STOLLE REGIME AND ENABLING CORRUPTION: THE INFLUENCE OF THE "STOLLE REGIME" IS ALLOWING ONGOING CORRUPTION TO PERSIST**

IN VIRGINIA BEACH. COMMONWEALTH ATTORNEY COLIN STOLLE, IS IMPLICATED IN ACTIONS THAT SUPPORT AND ENABLE THESE SYSTEMIC ABUSES.

**MEDIA COMPLICITY IN COVER-UP:** LOCAL MEDIA, FINANCIALLY TIED TO MR. HOLCOMB THROUGH ADVERTISING CONTRACTS, APPEARS COMPLICIT IN MANIPULATING PUBLIC AWARENESS. ON OCTOBER 21, 2024, REPORTER REGINA MOBLEY OF WAVY 10 SCHEDULED AN INTERVIEW WITH PEACEMAKER ALDO TO DISCUSS ROLIN'S CASE AND RELATED ISSUES. HOWEVER, WAVY 10 MANAGEMENT PROHIBITED THE COVERAGE ON OCTOBER 22, 2024, BLOCKING THE STORY FROM TIMELY REACHING THE PUBLIC. THIS FAILURE OF PUBLIC TRUST MANIPULATES PUBLIC OPINION AND SUPPORTS THE ONGOING COVER-UP.

**COVER-UP OF CRIMINAL ACTIVITIES:** THE ONGOING INVESTIGATION AND WITHHELD VIDEO EVIDENCE SUGGEST AN EFFORT TO CONCEAL NOT ONLY ROLIN'S CASE BUT POTENTIALLY OTHER CRIMINAL ACTS. THIS ONGOING COVER-UP DISTORTS JUSTICE AND SHIELDS OFFICIALS FROM ACCOUNTABILITY, DENYING JUSTICE FOR ROLIN AND OTHERS AFFECTED.

**LEGAL BASIS FOR MANDAMUS:**

**DUTY TO UPHOLD JUSTICE AND TRANSPARENCY:** UNDER BOTH THE U.S. AND VIRGINIA CONSTITUTIONS, AS WELL AS VIRGINIA CODE § 48.1, WHICH PROVIDES FOR THE EMPANELING OF A SPECIAL GRAND JURY WHEN FIVE OR MORE CITIZENS, NOT LIMITED TO BAR MEMBERS, BRING EVIDENCE BEFORE THE COURT, OFFICIALS ARE OBLIGATED TO MAINTAIN TRANSPARENCY AND ACCOUNTABILITY. THE FAILURE TO DISCLOSE CRITICAL INFORMATION AND THE MANIPULATION OF MEDIA COVERAGE DEMONSTRATE A SEVERE BREACH OF THIS DUTY, ERODING PUBLIC TRUST.

**DEMAND FOR NON-GOVERNMENT CITIZEN GRAND JURY OVERSIGHT: PEACEMAKER ALDO AND PETITIONERS DEMAND NON-GOVERNMENT CITIZEN GRAND JURY OVERSIGHT, SECURED THROUGH THE SHERIFF'S LAWFUL AUTHORITY, TO PREVENT INTERFERENCE AND RESTORE PUBLIC TRUST. GIVEN CONCERNS OF MANIPULATION WITHIN THE CURRENT UNLAWFUL GRAND JURY SYSTEM, WE REQUEST THAT THE COURT MANDATE AN INDEPENDENT SPECIAL GRAND JURY EMPANELED UNDER VIRGINIA CODE § 48.1.**

**RELIEF SOUGHT:**

**CALL FOR RESIGNATIONS: DUE TO THE BREACH OF DUTY AND ONGOING COVER-UP, PETITIONERS FORMALLY REQUEST THE RESIGNATION OF:**

**MANDATE TRANSPARENCY: IMMEDIATE PUBLIC RELEASE OF ALL RELEVANT VIDEO AND AUTOPSY EVIDENCE CONCERNING ROLIN HILL'S DEATH.**

**EMPANEL A SPECIAL GRAND JURY: REQUEST FOR THE COURT TO MANDATE A NON-GOVERNMENT CITIZEN SPECIAL GRAND JURY TO INVESTIGATE ALLEGATIONS OF ABUSE AND CORRUPTION WITHIN THE VIRGINIA BEACH JAIL, JUDICIAL, AND POLITICAL SYSTEMS, ENSURING NO POLITICAL OR JUDICIAL INTERFERENCE.**

**RESTORE PUBLIC TRUST: BY ENFORCING ACCOUNTABILITY THROUGH RESIGNATIONS AND FULL DISCLOSURE, THIS ACTION AIMS TO RESTORE PUBLIC CONFIDENCE IN LAW ENFORCEMENT AND LOCAL GOVERNANCE.**

**WHEREFORE:**

**PETITIONERS URGE THE COURT TO TAKE SWIFT, DECISIVE ACTION TO UPHOLD JUSTICE FOR ROLIN HILL AND ALL THOSE AFFECTED BY SYSTEMIC ABUSES. THIS WRIT SEEKS TRANSPARENCY, ACCOUNTABILITY, AND AN END TO CORRUPTION THAT DISTORTS BOTH JUSTICE AND DEMOCRACY.**
